Evaluation Procedure



Based on the results of tender evaluation the Evaluation Commission has made the following decision:

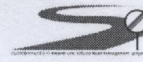
